#### PART III CBDC - CENTRAL BANK DIGITAL CURRENCY

Central Bank Digital Currency (CBDC) is the digital form of a country's fiat currency, which is regulated by its central bank. They have yet to be launched on a large scale, but advocates envision that they will replace national paper currencies. CBDCs will use a digital token on a computer network to represent a national currency. It will rely on blockchain technology. They will be used as a payment system.

In 2021 two House Representatives (one Democrat, Bill Foster and one Republican, French Hill) introduced the Central Bank Digital Currency Study Act of 2021 that would study the impact of introducing a United States CBDC. They also wrote a letter to the Federal Reserve asking the agency to start considering the possibility of a CBDC.

which you currently cannot get, but experts believe this will change as more CBDCs become worldwide.

How to implement CBDC is another issue. It must be available to all people not just those with the latest smartphones. It could be a chip-based card. point of sale system or a web account. You need a Wi-Fi network to work digitally. There is a lot to be done before a Central Bank Digital Currency can be implemented.

Along with the implementation issue there are disadvantages of CBDC such as a steep learning curve. People will need to learn how to open a digital wallet or store digital assets securely. The digital transaction if also irreversible, which means you cannot stop it if there is a mistake or fraud has taken place. Also not so obvious is the expense of this technology. Computers must solve complex equations to verify and record transactions and this takes considerable electricity. How will we have enough electricity if everything in society is computerized and needs to run on electricity? Another disadvantage will be the government's cost to create and develop a CBDC and to overhaul the entire global monetary system. All sellers of goods and services will have to accept digital currency. This will take a total reset of the world's economy and may take many years to achieve.

Hello again, we are "back to our roots" with another culinary adventure for you. This trip took us to the Chill and Grill, 7401 US Highway 1, Vero Beach. This is where the Food Scoop was

born over a few glasses of wine and lots of laughs. We agreed dining should be a fun experience shared ChilleGI with friends and what better way



than to plan to try different restaurants and dine together once a month, and then share it with our Park Place neighbors. We hope you enjoy reading this as much as we enjoy bringing it to you.

The Chill and Grill is open Tuesday through Sunday 5:00 to 9:00 pm and has a menu that focuses on fresh local ingredients and simple Southern and Home-style cooking with a dash of Asian, a pinch of French and a sprinkling of Cajun. Their menu is varied and includes specials every night along with sandwiches for those that just want a light bite. Chef Scott has enjoyed 30 plus years of experience cooking his way across the United States.

We arrived promptly at 5:00 and were seated immediately. We were greeted by our waitress, Angel. who was cheerful and explained the specials offered that evening. After we ordered our drinks, she gave us time to look over the menu. As we looked around the restaurant we were also charmed by the [[[[] décor which has a Caribbean, Jimmy Buffet, parrot head vibe that somehow works very well.

On to our menu! We started with three different appetizers: Beet salad with crumbled goat cheese. small slices of orange on a bed of fresh greens and a light balsamic vinaigrette \$9.99; Wood Oven Roasted Olives with feta cheese, roasted garlic and Naan (with stones) \$16.99; Smoked Ribeye Chili Mac 'n' Cheese (enough for 2), \$14.99. All of the appetizers were delicious. On to our entrees: Asian Glazed Half Duck, asparagus served atop saffron rice, this was a "special" for the night \$32.99; Blackened Mahi, green beans, mango salsa atop saffron rice, this too was a "special" for the night \$30.99; Smoked Shrimp and Grits; andouille, white wine-garlic butter, 6 to 8 shrimp \$23.99; Smoked Sliced Brisket Dinner, collards, Mac n cheese, BBQ sauce, generous portion with melt-inyour mouth brisket \$26.99. All the entrees were EX-CELLENT! On to dessert: Key Lime Pie \$8.99 and Peanut Butter pie \$8.99 with vanilla ice cream. Both were wonderful.

We waited a little while for our entrees to be delivered but we all agreed it was well worth the wait. Also, the appetizers and entrees were very generous servings, we definitely left with "doggie" bags.

As a side note about our rating system, we wanted to remind everyone that we rate 1-5 with 5 being the best and 1 the worst (HOPEFULLY we don't have any of those!) Unanimously, our rating for the Chill and Grill was a solid 5!




#### **BITS & PIECES**

#### FMO LEGISLATIVE UPDATE

Now that the 2024 Florida Legislature has gone home, we are pleased to report on the successful passing of the FMO sponsored changes to Section 723 of the Florida code.

As reported in a Watch Dog Alert on March 4<sup>th</sup>, to FMO members, after two legislative sessions we were able to get most of the proposed changes approved by both houses and on their way to the Governor for signature.

First, a big **<u>THANK YOU</u>** to all of you who participated in activity that supported this year's FMO legislation! You know who you are and you really made a difference! In the first House subcommittee the Democratic Ranking Member told our House sponsor he was glad to finally get to vote on her bill because he could go and clear his emails...he had received over 1,100 emails supporting the bill! That is amazing, folks! Good Job! You really define the term "People Power."

Second, another big **THANK YOU** to our Senate and House sponsors!! Senator Colleen Burton, (part of Polk County), filed SB 1140 and Representative Paula Stark, (parts of Orange and Osceola counties) filed HB 613. Each of our sponsors was fully engaged throughout the entire process in order to "land this plane!!"

The final version, <u>https://www.flsenate.gov/</u> <u>Session/Bill/2024/613/BillText/c3/PDF</u> gives HOA's more flexibility in trying to get community owners to the mediation table on rent and amenity issues. It provides a pathway for the parties to go directly to mediation without first going through the DBPR. It also requires the DBPR to act within 20 days if a petition for mediation is submitted. This is key in preventing proceedings from dragging on to the detriment of the residents.

It also gives greater protection for residents that employ "care givers". A background check, paid for by the home owner is required but the community owner cannot restrict entry by "care givers".

You may consider these to be small victories but the efforts of FMO and its members in contacting legislators did work. Given the dollars spent by FMO versus the dollars spent by the community owners association, we will take this victory and move forward.

#### Tax Time Scams

#### Don't fall for these sneaky tax scams that can steal your Identity and money.

Tax season isn't fun for most people, but it can be downright miserable if you fall for a scam. This year, there's been a noticeable uptick in scam callers impersonating IRS officials, and with the rise of AI voice programs, these scams have become more convincing than ever.

Last year, the IRS flagged 2.4 million tax returns with refunds totaling roughly \$13.8 billion for possible identity theft. Identity thieves use stolen information - like your SSN, name, address, and more - to file fraudulent tax returns in your name.

Meanwhile, The Better Business Bureau's (BBB) Scam Tracker collects reports on tax scams that come from the public. For scams reported as tax collection to BBB's Scam Tracker in 2023, the median dollar loss was \$2100.

Specific signs of tax-related identity theft:

- If you try to file your tax return **by mail** and receive a letter from the IRS stating that they have already received a return in your name, that could mean your identity has been compromised.
- Also, if you go to file your tax return **electronically** and the IRS alerts you that someone filed for your return using your Social Security Number, then you have likely been a victim of identity theft.
- Lastly, if the IRS sends you a letter stating that you have created a **new online account** and you know that you didn't, that is a dead giveaway that your identity may have been stolen.

Stay safe with these 8 tips from the Better Business Bureau

- Tip #1 File early: Filing early is one of the most sure-fire ways to keep yourself safe during tax season. If you file as soon as possible, there's less of a chance someone can steal your identity by filing your taxes before you do. Always make sure to have all of your tax documents ready when you start to file.
- Tip #2 Know how the real IRS will contact you: The IRS doesn't send emails, and their agents will never text you or contact you on social media. Typically, the IRS will only contact you through postage mail, but there is a chance that an IRS agent may perform an inperson visit, but only after confirming the visit via postage mail.

**Tip #3 – Get an identity protection PIN (IP PIN) from the IRS:** An easy way to add an extra layer of security to yourself is by getting an Identity Protection PIN, or IP-PIN, from the IRS. An IP-PIN is a six-digit number uses to confirm your identity. It can help identify you even when someone nefariously has accessed your Tax ID and social security number. Signing up for an IP-PIN is easy and can be done online at IRS.gov, and the IRS will mail you a new IP-PIN after you opt-in every December.

- Tip #4 Know how the IRS accepts payments: The IRS never demands immediate payment and will never ask for a credit card number or bank information over the phone. Never, under any circumstances, pay any money to someone claiming to be an IRS agent asking for cryptocurrency, digital gift cards, or wire transfers.
- Tip #5 Know the signs of fraud: If the IRS informs you that either your return has already been filed or that you received wages from an employer you aren't familiar with, you need to visit an IRS office in person as soon as possible to ensure you haven't fallen victim to fraud.
- **Tip #6 Protect your information:** Ensure you keep all documents related to your taxes in a secure location, such as a home filing cabinet or on a password-protected computer. Generally, never give out your social security number unless absolutely necessary.
- Tip #7 Only use secure filing websites: Always make sure you are accessing the real IRS website by checking that the URL is spelled correctly. Look for the lock symbol next to the URL in your browser's search bar to tell you that your connection to the IRS's website is secure.
- Tip #8 Report any suspected scams: If you receive a phone call or email asking for important tax information, hang up immediately. Report the call first to the IRS. Next, you should make a report to the Federal Communications Commission (FCC). Finally, head to the Better Business Bureau and report the scam to their scam tracker. 

#### "Moving" into Park Place 1993

Did you ever think you wanted to move out of the Park but hated to leave your house? Maybe a raise in rent or some other change put those thoughts in your mind. Well for a number of Park Place residents that's exactly what happened to them. However, that's not how they moved out of Park Place, but how they moved IN – with their homes!

Four families from the Lakes of Melbourne community, in 1993, were unhappy with an increase in market rent and a decrease in amenities. One of them. Muriel Johnston, was on the HOA and saw no solution to the issue so she and three other families made the decision to move. On a cruise, a few years back, Mary and Jack Meehan from the Lakes of Melbourne had met two couples, the Tuckers and the Petchs who lived in Park Place and were happy there. In 1993, it happened that Nelson Hyatt was actively developing Park Place and was offering "Lifetime Leases" which made their decision easy! They also heard about the option to buy a lot there, but details were too sketchy at the time. They soon learned, according to Mary, that they could have bought lakefront lots for \$30,000, a corner lot for \$20,000 and an interior lot for \$15,000.

Betty and Barney Marlow were another family to make the move. Betty told me it cost \$19,000 to move her home here. She said she didn't have to empty the house. She put the dishes away, they taped up all the doors, covered the open middle of the home with plastic and put each half on a flatbed and off they went down Route 1! Of course that's just the house, not the shed or carport or screen room. Mary remembers having lunch with Jack along Route 1 and seeing her house go by!!

The Meehans (1045 W. Lakeview), the Marlows (1043 W Lakeview), Muriel Johnston (2303 Kelly), and John and Joanne Mangino (2300 Kelly) made the move. Mary and Betty were friends and chose lots side by side. Mary's adopted sister Muriel and the fourth family chose the first homes on Kelly Drive.

Neighbors in Park Place weren't happy at first. Usually, a home was ordered or built on spec at a location, then other structures like carport and shed, plus landscaping, were in place before anyone moved in. Now these homes just appeared, and Betty told me there were complaints about the lack of landscaping and missing brick front when these homes arrived. Betty showed her neighbors photos of her home before she moved, Hyatt added landscaping, and the neighbors were satisfied.

The "Kitchen Angels" program idea came with Mary from the Lakes of Melbourne, and she helped organize it here. For many years they provided the food for memorial services held in the Park for the convenience of the grieving families of deceased Park Place residents. That much appreciated service lasted many years until recently when families, or the deceased themselves, did not wish to have a service. when Cheryle and John Johnson moved into the park in 1997. In all, I understand 12 lots were sold in that period as Hyatt was developing on a "shoestring" budget. A change of ownership, circa 1998, ended that option. But that's a story for another day.


